

### **\$1 A Day Charity Impact Statements**

#### Animal Friends Alliance | www.savinganimalstoday.org | Animals

\$1 a day enables Animal Friends Alliance to provide: four pounds of food every day for pets whose owners are experiencing financial hardship; and, surgery to spay/neuter four cats or dogs awaiting adoption.

**Big Brothers Big Sisters of Southwest Colorado** | www.bbig.org | Children and Youth \$1 a day enables Big Brothers Big Sisters of Southwest Colorado to fund the enrollment and recruitment of one child and the mentor who will lead them toward a more successful future.

Brigit's Bounty Community Resources | www.brigitsbounty.org | Children and Youth \$1 a day enables Brigit's Bounty Community Resources to provide one week of Summer Garden Camp to a child from a low-income household in Weld County.
